Data Governance (DG) refers to the authorization and overall management of the ownership, availability, usability, integrity, and security of the data used across an enterprise, with the primary goal of controlling data quality. Typically Data Warehousing is the entry point on the data management maturity spectrum followed by Master Data Management (MDM). At any juncture along this spectrum Data Governance can, and should, be introduced as part of a clear strategy to control data quality through the ownership and comprehensive management of data.
